I agree to abide by the following rules & regulations:

- THE USE OF GAS BLOWERS IS PROHIBITED FROM THE FRIDAY BEFORE MEMORIAL DAY THROUGH LABOR DAY MONDAY UNLESS FITTED WITH A MUFFLER DEVICE NOT TO EXCEED 70 DECIBELS. ELECTRIC BLOWERS MAY BE USED INSTEAD.
- WORK IS PERMITTED MONDAY FRIDAY, 8:00 AM 6:00 PM, and <u>SATURDAY 9 AM 5 PM</u> QUIET WORK ONLY SUCH AS SEEDING, FEEDING, WEEDING, MULCH, ECT.
- NO WORK WITH POWER EQUIPMENT PERMITTED ON SATURDAYS, AND NO WORK OF ANY KIND ON SUNDAYS or FEDERAL HOLIDAYS. (The minimum fine is \$500.)
- LEAVES MAY NOT BE BLOWN INTO THE STREET. LANDSCAPER IS RESPONSIBLE FOR DISPOSING OF ALL YARD WASTE NO DUMPING ANYWHERE IN THE VILLAGE. BAGS OF DEBRIS MAY NOT BE LEFT FOR THE VILLAGE CARTER.
- ALL MACHINERY AND CONTAINERS MUST SIT ON DROP CLOTHS. OIL AND GAS MUST BE POURED FROM ONE CONTAINER TO ANOTHER OVER A DROP CLOTH.
- IT IS FORBIDDEN TO SPILL ANY OIL, GAS, FERTILIZERS OR PESTICIDES ON THE STREET OR GROUND.
- DO NOT CUT DOWN ANY TREES WITHOUT A VILLAGE PERMIT (DEAD OR ALIVE).
 PERMIT FEE FOR REMOVAL: LIVE TREE, \$150.00 PER TREE; DEAD OR DAMAGED TREE, \$50.00 PER TREE.
- EVERY LANDSCAPER'S VEHICLE MUST HAVE A VILLAGE OF FLOWER HILL REGISTRATION STICKER ON THE LEFT REAR BUMPER. (TRAILERS INCLUDED) with the <u>minimum summons</u> <u>fine of \$50</u>. For each vehicle without a sticker
- SNOW MAY NOT BE SHOVELED OR PLOWED INTO ANY VILLAGE ROADWAY.
