VILLAGE PROPERTY TAX GRIEVANCE DEADLINE IS FEB. 21

The 2012/13 Village of Flower Hills Tentative Assessment Roll is available for public review from Tues., Feb. 7 until Tues., Feb. 21, 2012. Feb.21, 2012 is the last day to file a grievance on the 2012/13 Tentative Village Assessment. Your complaint must be received by this date. We require an original plus 3 copies of each complaint submitted. Please remember to include any supporting documentation with your complaint. You must verify the Tentative Assessments in your complaint against the published 2012/13 Village of Flower Hill Tentative Assessment Roll prior to submission. Complaints filed with incorrect assessments will be denied. If you are dissatisfied with the determination of the Board of Assessment Review, you may seek judicial review of your assessment pursuant to Article 7 of the Real Property Tax Law (RPTL). Petitions for judicial review must be filed within thirty (30) days of the last date allowed by law for the filing of the final assessment roll (April 1), or the published notice of such filing, whichever is later. Petition forms for Small Claims Assessment Review may be obtained from the Nassau County Clerk's Office.***Please note that even though the Village of Flower Hill is an assessing unit the Village adopts the Nassau County Assessment Roll. The roll that is made available to the Village of Flower Hill is received on or before April 1st**

SNOW SEASON REMINDER

Please remember that the snow plows are unable to plow properly when cars are parked on the roads. Parking is prohibited on Village streets when two inches or more of snow has fallen or is forecast by the National Weather Service. This will allow all streets to be plowed curb to curb. Parking may be resumed when the snow has stopped falling and the roads are cleared.

Please be courteous to your neighbors and **DO NOT shovel snow from your driveway back into the plowed street**. The Village Code Enforcer patrols the streets after the plows have gone through and will issue a summons if snow is shoveled or plowed back into the roadway. When snow is pushed back onto the road after is has been cleared it tends to ice over and cause hazardous conditions.

We receive many complaints that our plows block driveways with snow, this is because there is nowhere else for the snow to go. Please shovel that snow back onto your lawn. It will melt!

You must plow out your own driveway., our drivers cannot do it for you. If you use a plow service, please advise your contractor that they may **not** plow the snow from your driveway onto the road or your neighbor's property, they must plow it back onto your property.

Please follow these guidelines so that a winter storm only becomes an inconvenience and not a danger.

WINTER SAFETY TIPS

The effect of a winter storm on your home and property can be significant. Addressing of storm exposure in advance is the best way to reduce loss potential. The following guidelines may be beneficial in reducing the negative effects of winter conditions:

- Inspect and repair roofs.
- Ascertain the ability of roofs to withstand possible heavy snow accumulation to prevent collapse.
- Inspect roof drains. Clear all debris that of could cause clogging.
- \bullet Check sump pumps for proper operation $_{\odot}$ to prevent flooding.
- Check that exposed pipe has been properly insulated.
- Check that sprinkler system has been drained and winterized.
- Check that generators are operational.
- Ensure that temporary heaters are UL listed and approved and have adequate clearance from any combustible materials.

TRASH PICK UP

Please <u>do not</u> bring your garbage to the curb on pick up days. The carting company, will come to your side yard or backyard to pick up your garbage. If you have a large, heavy or unwieldy item you will need to call the carting company to arrange for a special pickup, in which case you should bring the item to the curb no earlier than the night before the scheduled pickup. You are entitled to one large item for pickup per week and should make arrangements in advance with Meadow Carting directly by calling 338-0121.

WHAT CAN BE RECYCLED?

RECYCLING PAPER & CARDBOARD YES NO Newspapers, magazines Hardcover books & catalogs Envelopes with plastic White or colored paper windows Cardboard drink con-Construction & wrapping paper tainers Index & greeting cards Telephone books Paperback books Cereal boxes, waxed paper Corrugated cardboard Take out containers

Pack in brown grocery bags or tie with twine, flatten cardboard and tie in bundles approximately 2'x2"x6". Place on top of or next to your recycling can.

RECYCLING METAL, GLASS & PLASTIC

YES

- Metal cans, foil wrap & trays (labels removed)
- Plastic bottles & jugs made of PETE or HDPE plastic
- Clear & colored glass bottles & jars (no lids)

NO

- Styrofoam or plastic bags
- Motor oil, paint containers or pesticide containers
- Aerosol cans
- Mirrors, windows, safety glass
- Light bulbs
- Ceramics, drinking glasses, broken glass

All containers must be rinsed with labels removed. Place in recycling can.

RECYCLING CONTAINERS

There is no requirement that you use an official Town of North Hempstead recycling can. If you would like to obtain a Town container, they are available at the Town of North Hempstead Solid Waste Management facility at 802 Shore Road in Roslyn. They are open from 9 to 4:45, Monday through Friday. The cans are \$12 each and proof of Town residency is required for purchase. You may also use a recycling container purchased at any hardware store or home center. If the container is not marked "Recycling", we recommend labeling it with a permanent marker. It's also a good idea to put your address on the container in the event the wind blows it away.
